- Support sustainability through TTA surrounding the implementation of new policies/practices and enhancement of existing policies/practices







Strengthening the ME/C System Program: Solicitation Overview

Program Background:

The medicolegal death investigation (MDI) workforce is experiencing a national shortage of practicing, board- certified forensic pathologists. Furthermore, there is variability in the practice of death investigation across the United States, resulting in an inconsistent provision of MDI services.

Created in Fiscal Year (FY) 2017, the ME/C Program is a competitive and discretionary grant program designed to help address medical death investigation workforce needs to increase the number of practicing board-certified forensic pathologists, and ME/C offices need to implement and follow quality standards and performance criteria, in an effort, to provide consistent and equitable application of death investigation services.

Strengthening the ME/C System Program

- BJA funds applications to strengthen the ME/C system by increasing the number of qualified forensic pathologists and enhance the quality of medicolegal death investigations nationwide.
- This program furthers the DOJ's mission to uphold the rule of law, to keep our country safe, and to protect civil rights by providing resources to improve medicolegal death investigations (MDIs) in the United States.
- Two purpose areas are funded under this program:
 - 1. Forensic Pathology Fellowships (up to two allowed, per application).
 - 2. Medical Examiner Coroner Office Accreditation.
- Purpose Area 1: Forensic Pathology Fellowships
 - Recruit quality candidates who have completed all the necessary medical education and pathology residency requirements by soliciting applications from institutions with current Accreditation Council for Graduate Medical Education (ACGME) accredited forensic pathology fellowship programs.



Benefits of the Fellowship Purpose Area

- Increase the number of qualified forensic pathology practitioners.
 - The medicolegal death investigation (MDI) workforce is experiencing a national shortage of practicing board-certified forensic pathologists.
- Since the program was initiated in 2017, funding under the Fellowship/Purpose Area 1 has resulted in:
 - \circ 61 fellowships funded.
 - o 43 participants completed fellowship training.
 - \circ 10,710 deaths investigated by fellows.
 - \circ 11,540 autopsies performed by fellows.







Allowable Uses of Funds

Purpose Area 1: Fellowships

- Salaries/Stipends and Fringe Benefits
- Loan Repayments
- Recruitment Travel
- Minor Equipment and Supplies
- Training
- Medical License Reimbursement







Allowable Uses of Funds

Budget Information for BOTH Purpose Areas

- Training To attend BJA's forensics grantee workshop.
- No-Cost Extensions
- Certification Fees







Loan Repayment Option

To offset the financial burden associated with educational debt and assist with recruiting qualified candidates may apply for the following:

Number of Fellows	Maximum Allowable Award Amount	Maximum Allowable Loan Repayment Amount
1	\$150,000	\$75,000
2	\$300,000	\$150,000 (\$75,000/Fellow)

Please Note:

- The loan is paid to the agency directly through the ME/C award as long as it is properly documented in their approved budget.
- Only the <u>grant-funded</u> fellow qualifies for the loan repayment offered through the ME/C program (fellows not funded through the ME/C program are not eligible).
- The applicant/grantee should consult with an accountant or a tax lawyer regarding tax implications associated with the loan repayment. OJP will not be able to provide advice on this issue.
