Program Overview

FY 2024 Postconviction Testing of DNA Evidence (PC) Program

The FY 2024 Postconviction Testing of DNA Evidence (PC) Program is a competitive grant program designed to defray the costs associated with postconviction DNA testing in cases of violent felony offenses (as defined by state law) in which actual innocence might be demonstrated.

Two funding categories this year!



Main Objectives – Category 1

- 1. Identify potential postconviction DNA testing cases. A maximum of 15 percent of the proposed budget may be dedicated to case identification activities.
- 2. Review appropriate postconviction cases to identify those in which DNA testing could prove the actual innocence of a person convicted of a violent felony offense as defined by state law.
- 3. Locate biological evidence associated with such postconviction cases.
- 4. Perform DNA analysis of appropriate biological evidence and report and review the DNA test results.









Main Objectives – Category 2 – New!

- 1. Locate, record, store, and retain biological evidence in adjudicated cases in accordance with best practices.
- 2. Modernize evidence retention practices for biological evidence in accordance with best practices.
- 3. Modernize and digitize the storage of existing files and records in adjudicated cases.
- 4. Implement modern, digitized file and record retention systems.







Solicitation Highlights

Case Identification

Performing outreach or initial screening activities, other than "case review" as defined below, designed to identify postconviction cases of violent felony offenses (as defined by state law) where DNA analysis might demonstrate actual innocence.

In previous years, there was a restriction of no more than 15% of the budget that could be used for this purpose – this restriction has been removed in FY24









Solicitation Highlights

Case Review: Review of files or documentation of postconviction cases of violent felony offenses (as defined by state law) by appropriate persons (e.g., prosecutors, public defenders, law enforcement personnel, and medical examiners) to determine whether biological evidence exists that might, through DNA analysis, demonstrate the actual innocence of the person previously convicted.





Forensic Genetic Genealogical (FGG) DNA Analysis and Searching

Award recipients utilizing funds for forensic genealogy testing must adhere to the United States Department of Justice Interim Policy Forensic Genealogical DNA Analysis and Searching, available at: <u>United States Department of Justice Interim Policy: Forensic Genealogical DNA Analysis and Searching</u>.

In accordance with Section IX, grantees must collect and report specific performance metrics to BJA.



Allowable Uses of Funds

All expenditures under this program must relate directly to defraying the costs associated with postconviction DNA testing.

Some examples include:

Salary and benefits of additional employees, temporary personnel, or OT for individuals directly engaged in the objectives of the program/category.

Victim Advocates. New in FY24!

Laboratory supplies.

Training directly related to the four objectives of the program.

Contracts with accredited DNA laboratories for DNA analysis.





Unallowable Uses of Funds

Costs associated with civil litigation related to the original criminal conviction

Salaries, benefits, or overtime for staff who are not directly engaged in objectives of category/program

Laboratory equipment, instrumentation, and software such as, but not limited to, genetic analyzers, DNA extraction robotics, and probabilistic genotyping software

Construction/ Renovation

Prohibited and controlled equipment, consistent with Executive Order (EO) 14074, per OJP policy

Witness travel

Office furnishings

General litigation training or training that is not relevant to postconviction work involving DNA



Direct administrative expenses that exceed 5 percent of the federal portion of the award


Unmanned aircraft systems (UAS), including unmanned aircraft vehicles (UAV), and all accompanying accessories to support UAS or UAV



Meaningful access requirement for individuals with limited English proficiency

The recipient, and any subrecipient at any tier, must take reasonable steps to ensure that individuals with limited English proficiency (LEP) have meaningful access to their programs and activities to comply with Title VI of the Civil Rights Act of 1964 (Title VI), which prohibits discrimination on the basis of national origin, including discrimination against individuals with LEP. FY24 Postconviction Requirements



Bi-annual check-in calls (usually ~April and ~October) with BJA and must include the grantee financial manager, grant manager and principal investigator



BJA requires that grantees attend the Virtual Grantees Conference held annually by Forensics TTA. Up to 3 key personnel may attend the conference.



Semi-annual progress reports must be submitted.

FY 2024 Postconviction Performance Management

- Performance reports are required semi-annually
- Responses are input in PMT and uploaded to JustGrants
- Review section headers for critical reporting information

What are the Postconviction Performance Measures?

CASE REVIEW

An occasion on which someone compensated for this work with award funds looks through any paperwork or documentation associated with the identified case to determine whether biological evidence exists that might, through DNA analysis, demonstrate the actual innocence of a person previously convicted. Regardless of how many times a case was reviewed during the reporting period or by how many grant-funded staff, all reviews of a single case will count as one (1) review for the purposes of reporting during a single reporting period. If a case is reviewed again during a later reporting period or had been reviewed and recorded as a case review under another BJA award, it should then be counted under "continuing" case reviews.

What are the Postconviction Performance Measures?

29. During the reporting period, did any postconviction DNA case yield a viable DNA profile, even if the profile was inconclusive with respect to the postconviction claim? A profile is a genetic sequence related to an individual contributor. A viable DNA profile is a full or partial DNA profile, or mtDNA sequence, that can be uploaded to Combined DNS Index System (CODIS) or could be used to compare against other DNA profiles such as the postconviction claimant's profile. One case may generate one or more profiles. The case is related to the incident where the evidence was gathered. This does not include reference samples from victims or defendants.


